I will also read and follow the Colorado State Law concerning the unlawful alteration of livestock, where applicable, by tampering or sabotage and the United State Department of Agriculture Wholesome Meat Act. I will ask that my parents and supervisors also understand and follow these rules and not make or ask for exceptions on my behalf. I wish for my animal project to be an example of how to accept what life has to offer – good or bad – and how to live with the outcome.

I understand that I am responsible for the proper care and treatment of my animal, the production of wholesome food, where applicable, and the development of sound moral character.

I understand only immediate family members or other La Plata County 4H/FFA members will be allowed to assist the exhibitor in preparing the animal for show including washing, grooming or fitting. I understand as the exhibitor I must be present and learning from the assistance.
